Revitalist Lifestyle and Wellness Provides Update on Clinic Operations and Innovative Service Offerings

VANCOUVER, BC, August 31, 2021 – REVITALIST LIFESTYLE AND WELLNESS LTD. (“Revitalist” or the “Company”) (CSE: CALM) (CSNX: CALM.CN) is pleased to provide a comprehensive update on its clinic operations and expansion plans.

“Revitalist was founded in 2018 with a single clinic and a goal of providing innovative therapy and treatment options to those suffering from mental health and pain related conditions. Today, we have partnered with industry leading media and capital markets advisors to raise CAD\$8,300,000 and expand our footprint to four clinics in four months across two States with three additional clinics expected to open in the Fall of 2021,” stated Revitalist Founder and Chief Executive Officer, Kathryn Walker.

Clinic Operations

- Revitalist first opened in 2018 in Knoxville, Tennessee. This location now serves in the lead role for clinics and operators supporting clients and chief operators in training, support, and development.
- The Company continues executing on its multi-stage strategic clinic roll out strategy and has expanded to five clinics across two U.S States including; Knoxville, TN, Johnson City, TN, Chattanooga, TN, Louisville, KY, and now Raleigh, NC (With an opening date of September 1).
- Revitalist expects to have two additional clinics operational by the end September and October of 2021 with one lease executed and another in final negotiations.

According to a recent industry research report by Stifel GMP, the addressable market opportunity for psychedelic-assisted psychotherapy (“PAP”) clinics is approximately US\$10-11 billion in the United States with a focus on Major Depressive Disorder. This excludes the many additional key neurologic conditions that psychedelics are actively addressing in real time. The Company is well positioned to capitalize on this market opportunity with continued execution of its strategic clinic expansion plan, proven leadership and extensive medical and mental health experts that are specialists in a wide variety of conditions that are directly related to the services they provide.

Revitalist is in a unique position in the fact that each location is supporting the next location in leadership and training. “While the flagship is in Knoxville, Tennessee, we are training our leadership team at each location to support each other by actively engaging various ways to best support our clients and team members,” states Kathryn Walker, “I am the CEO of the next generation of leaders,” continued Walker.

“The scalable actions that are currently taking place by having the corporate headquarters create a waterfall effect maximizing efficacy and limiting cost among every Revitalist location is a strategic and exciting approach. The opportunity to get involved with a project of this size is now,” reports Larry Heinzlmeir, Chief Marketing Officer.

Revitalist continues to maximize their marketing efforts working with one of their strategic partners, Ketamine Media. Ketamine Media’s proprietary digital datasets for patient lead generation optimizing targeted geographic locations based on financials, demographics and costs of living allows a strategic approach to every Revitalist location.

Revitalist pairs best in class facilities with Certified Registered Nurse Anesthetists (“CRNAs”) by providing innovative, evidence based treatments to help patients with a wide variety of mental health and pain conditions. Treatments include but are not limited to; IV Ketamine Infusions, Ketamine-Assisted Psychotherapy, Spravato/Esketamine, Transcranial Magnetic Stimulation (“TMS”), Medical Infusions, Vitamin Infusions and Solution Based Therapies which are supported by industry leading evidenced based research.

Revitalist aims to provide the most effective treatment options in a variety of ways to best serve clients. “Our society is living in extremely scary times, and the question of trust and advocacy seems to be in small quantities. Revitalist will change this view. The treatments we provide are highly efficacious, and the experts we have in our clinics are not only known as Critical Care Experts, Pain Experts, and Airways Experts; they are also known as caring advocates who have been taught the importance of allowing others to feel heard.
